1. A Resolution on Reproductive Health Guarantees Via Constitutional Rights

WHEREAS, Consistent with the 14th Amendment of the Constitution, its limits on governmental powers, and the Bill of Rights, that no state government or institution may restrict rights and/or grant or allow greater liberties to any one person, individual group, or specified groups; and

WHEREAS, the term 'Person(s)', used in the 14th amendment, refers to the commonly accepted definition of the word, with no exclusions based on gender, race, ethnicity, age, sexual designation or orientation, nor physical attributes or any such affectations; and

WHEREAS, the amendment refers to all people (U.S. residents), not any one group, with no differentiation of rights between genders, or based on race, ethnicity, age, sexual designation or preference, and physical attributes or any such affectations; now, therefore, be it

RESOLVED,

- That women have complete control over their bodies and healthcare decisions, and we believe the 14th amendment of the Constitution guarantees this control, as it does for every male citizen.
- That a woman's decisions regarding pregnancy should be her own choice and not that of the government.
- That abortion procedures must be safe, legal, accessible to all North Carolina women regardless of ability to pay; therefore, the State abortion fund should be fully funded and accessible to indigent women.
- That every woman, including trans-identified individuals, should have access to prenatal and postnatal care, appropriate counseling, as well as access to information regarding all choices related to pregnancies.
- That we should focus on preventing unintended pregnancies and reducing the need for abortion through increasing access to family planning services, access to affordable birth control, including emergency contraception, and by providing fact based, comprehensive age-appropriate, sex education; and,

BE IT FURTHER RESOLVED, That the North Carolina General Assembly must ensure people's rights to reproductive freedom and complete bodily autonomy, as reflected by the 14th amendment's equal protection and non-discrimination clause.

WHEREAS, it is by an individual's own discernment that they may decide by what action or method may make them healthy; and

WHEREAS, these actions include seeking the opinion of medical professionals and, at times, authorizing medical, surgical or other procedures to produce their standard of health; and

WHEREAS, this is not a protected right when said action directly or inadvertently causes the health of another individual to decrease, such as refusing to guard oneself against transmissible diseases; and

WHEREAS, in recent years it has become of increased interest of many governments and individuals to determine for specific groups of persons what makes the individuals in said groups healthy; and

WHEREAS, this interest has become, and for the foreseeable future will be, a legislative priority for members of the conservative movement; and

WHEREAS, these legislative priorities have been undertaken without consideration or care that they will, by making them law, decrease the individuals freedom to to actions that will make them healthy; and

WHEREAS, access, trail maintenance and signage for many areas is inadequate; therefore

BE IT RESOLVED, that the Democratic Party supports increasing financial support for the National Forest Service for improved access, trail maintenance and signage at recreation sites located within our national forests.

WHEREAS, old-growth forests were once common in the Southern Appalachian Mountains, and are an important part of the region's cultural, economic, recreational, and natural history; and

WHEREAS, old-growth forests are now very rare due to exploitation, and make up less than 1% of the forests of the Eastern U.S., and less than 5% of the forests in the Southern Appalachians; and

WHEREAS, the best remaining old-growth forests are harbored on public land; and

WHEREAS, the Nantahala and Pisgah National Forests are the largest units of public land in North Carolina and the Southern Appalachians; and

WHEREAS, the Nantahala-Pisgah Forest Plan allows old-growth forest to be commercially logged despite over 15,000 objectors to the Plan (an unprecedented number); now, therefore, be it

RESOLVED, that the North Carolina Democratic Party calls for a prohibition against commercial logging in old-growth areas in our Nantahala and Pisgah National Forests.

RESOLVED, that North Carolina enact a full ban on producing and using single-use plastic bags.

BE IT RESOLVED that the NC Democratic Party urges new appointees to the North Carolina Utilities Commission should be committed to significantly reducing the use of fossil fuels with a goal of elimination as technology allows. FURTHER RESOLVED, that the State and Federal Government shall fund publicly-owned wind, solar, geothermal, and storage resources, with the goal of US energy production becoming 100% carbon neutral by 2040.

WHEREAS, despite being couched in language falsely claiming that certain books are "child abuse," "pornography," "indoctrination," or "promoting division," both the intent and impact of these book bans is to restrict student's access to accurate information about both the past and present lived experiences of marginalized groups, including but not limited to the experience of Black and LGBTQ+ Americans,

THEREFORE, BE IT RESOLVED THAT Democrats firmly denounce efforts to restrict access to books based on their content and reject censorship as a fundamentally un-American,

BE IT FURTHER RESOLVED THAT Democrats applaud the efforts of educators, authors, advocates, and others to share stories which reflect the perspectives and experiences of all Americans, particularly those which have not been widely known,

WHEREAS, the state of North Carolina sets very specific guidelines for the construction of a public school system calendar (North Carolina General Statutes §115C-84.2), including start and ending dates; and

WHEREAS, neither charter schools nor private schools are required to follow as strictly the traditional public school academic calendar mandated by the state; and

WHEREAS, waivers for weather disruptions of calendars, which can disproportionately affect the length of the two semesters, are now more difficult to get; and

WHEREAS, local School Boards are best equipped to determine the most appropriate starting and ending times for their school years as well as the most appropriate times to schedule breaks in that calendar; therefore

BE IT RESOLVED, that the state continue to set minimum standards for student contact hours and days, but allow greater flexibility for local determination of how those standards will be met.

WHEREAS, a party political label is more likely to obscure than define an individual candidate's qualifications, ability and educational philosophy essential to oversee the operation and administration of school systems; therefore

BE IT RESOLVED, that school board elections in Henderson County should remain non-partisan; and

BE IT FURTHER RESOLVED, that the North Carolina legislature should amend the law allowing party designations in school board elections to mandate non-partisan elections throughout North Carolina; and

BE IT FURTHER RESOLVED, that public (taxpayer) money is needed in, and belongs in, public schools; and

BE IT FURTHER RESOLVED, that party politics should NOT be injected between school and university boards and the communities they serve when it comes to design and implementation of curricula that treat all students equitably and inclusively.

BE IT RESOLVED that the Democratic Party of Henderson County seeks candidates for the NC General Assembly who will introduce and support legislation which will provide tuition equity for qualified DACA and undocumented students who graduate from a North Carolina high school.

WHEREAS, having lost public support over the issue of same-sex marriage, Republicans have continued abhorrent attacks on the rights of LGBTQIA+ Americans by targeting smaller sections of the LGBTQIA+ community that are less understood, especially transgender youth,

WHEREAS, prominent Republican leaders both in North Carolina and at the Federal level continue to make disgusting public statements disparaging LGBTQ+ Americans with alarming frequency,

WHEREAS, by May of 2021 that year broke a new a record for the highest number of anti-LGBTQ+ bills proposed in a single legislative session,

(https://www.hrc.org/press-releases/2021-officially-becomes-worst-year-in-recent-history-for-lgbtq-state -legislative-attacks-as-unprecedented-number-of-states-enact-record-shattering-number-of-anti-lgbtqmeasures-into-law)

WHEREAS, in 2021 three bills were proposed in the North Carolina General Assembly which would have made it illegal for medical providers to prove necessary medical care for transgender youth (SB514), created a "license to discriminate" for religious medical professionals (SB515), and prevented transgender athletes from participating in sports (HB358),

WHEREAS, existing state and federal anti-discrimination laws are not uniform or consistent, are subject to change at any time, and have proven unreliable before the courts as guarantees of equal rights; and

WHEREAS, the amendment contains only 58 words and says:

- Section 1. Equality of rights under the law shall not be denied or abridged by the United States or by any State on account of sex.
- Section 2. The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.
- Section 3. This amendment shall take effect two years after the date of ratification;

WHEREAS public officials in a democratic state are (or should consider themselves to be) in the employ of each and every citizen no matter their color, religion, social status, or economic status, and

WHEREAS, if a public official gives advice to one citizen, but not another, this is a violation of their responsibility to act in the common interest, and

WHEREAS, if a public official receives compensation or a gift from one citizen or group of citizens, all citizens deserve to be notified so as to be able to judge whether or not a conflict of interest might exist that would interfere with the official's ability to act fairly and without bias, and

WHEREAS it must be determined whether a donated gift is the property of the democratic state, or the public official who receives it, and

WHEREAS the history of the United States is replete with examples of violations of these basic principles, now therefor,

BE IT RESOLVED that the Democratic Party shall seek legislation at the federal and state level that would regulate these issues that compromise our trust in elected or appointed officials, and pose potential threats to our democracy itself, and that these regulations shall include the items listed below, and

- Before their election or appointment, candidates for elected or higher-level appointed office shall be required to submit their federal tax returns for public scrutiny for the most recent a) ten years for Presidential and Vice-Presidential candidates, and b) five years for other candidates.
- These elected or appointed officials shall also be required to provide their federal tax return for public scrutiny every year of their incumbency.
- The IRS shall be required to audit the federal tax return of these officeholders during each year of their incumbency.
- These elected or appointed office holders shall be required to provide their federal tax returns for public scrutiny for three years after leaving office.
- If any elected or appointed office holder provides advice or counsel to private individuals or entities, they shall publish such advice for public scrutiny; this includes information presented in lectures and at conferences that are not open to the public.
- All honoraria, awards, gifts, or other emoluments received by an elected or appointed office holder (and their immediate family) shall be reported for public scrutiny.
- Promulgated rules shall establish appropriate monetary value limits for such honoraria, awards, gifts, or other emoluments.
- These rules shall define acceptable sources, and acceptable purposes for such honoraria, awards gifts, or other emoluments.
- The donor of any honorarium, award, gift, or other emolument shall be required to state, in writing, the purpose of such a donation, to whom it is being given, and whether it is in compensation for a service provided by the office holder.

- Promulgated rules shall establish a mechanism for their enforcement, and appropriate penalties for their infringement, and
- These rules shall establish a mechanism to maintain records of the above and make them available for public scrutiny.

BE IT FURTHER RESOLVED that the Democratic Party shall establish enforceable rules that can be imposed on Democratic candidates and office holders in the presence or absence of any federal or state regulation.

WHEREAS, some people do not vote because they feel uninspired or uninformed, or otherwise lack motivation, and others may not vote because of physical handicaps or other physical barriers, and

WHEREAS, The base legislative salary of \$13,951 annually is incongruous with the ideals of a "citizen legislature" and, instead, limits legislative service to only those who can afford to otherwise supplement their legislative income; and

WHEREAS, This low base pay creates incentives for legislators to cater to private interests who can provide post-office benefits like jobs or more direct financial support; now, therefore, be it

RESOLVED, That the North Carolina Democratic Party and all its elected members support moving to a full-time state legislative model; and

RESOLVED, That the pay, resources, and staff of the state legislators be increased to match the additional work that would be required by this change; and

WHEREAS, The determination of voting thresholds by present and voting members rather than by total seats effectively disenfranchises the communities whose legislator is absent or otherwise unable to participate; and

WHEREAS, Legislative bodies often strategically "garage" votes until absences cause thresholds to fall as a way of bypassing the will of the majority to pass legislation or do other business that would normally not have the necessary support; and

WHEREAS, The absence of a legislator should not be taken as that community's disinterest or neutrality in the given business of government; and

WHEREAS, The threshold of votes fluctuating based on attending members leaves vulnerabilities in our democratic government in which actors supporting the passage of unpopular legislation can artificially lower the necessary thresholds of affirmative votes by blocking the attendance of opposed members; now, therefore, be it

RESOLVED, That the Democratic Party and all its elected members support changing the threshold requirements of public legislative bodies from present members to total seats of the body in all cases except under legislative emergency as dictated by the constitutions of the operating political entities; and

BE IT FURTHER RESOLVED, That additional voting methods be explored to allow for the greater participation of physically absent legislators.

WHEREAS, This delegation of authority is unnecessary in our modern world of rapid communication and transportation; and

WHEREAS, Unlike the other triggers for enacting the gubernatorial line of succession (death, resignation, removal from office, or physical or mental incapacity), absence from the state does not diminish the Governor's ability to serve their role as chief state executive; and

WHEREAS, This forced transference of power undermines the executive authority of the Governor by allowing such authority to be effectively sidestepped through the Lieutenant Governor when the Governor is required to leave the state, forcing a governor who wishes to retain that authority to remain in the state for the entire duration of their term; and

WHEREAS, This further limits the Governor's capacity to fill their role as chief representative of the state on matters that would take them outside of state lines; now, therefore, be it

RESOLVED, That the North Carolina Democratic Party and all its elected members support amending the North Carolina State Constitution to strike the offending language from the relevant subsection; and

BE IT FURTHER RESOLVED, That the Democratic Party and all of its elected members support amending state and territorial constitutions across the country to strike similarly offending language pertinent to their own state officials.

RESOLVED, That the minimum wage be increased after careful study to determine whether some employers should have to pay a higher minimum wage than others.

- 13. misclassifying employees as independent contractors; and be it

FURTHER RESOLVED, In the spirit of fairness, the penalty for theft by an employee should be no more severe than the penalty for wage theft by an employer.

WHEREAS Democrats seek evidence-based alternatives to the chronic involvement with the criminal justice system and emergency medical service in order to promote better overall community health;

WHEREAS Democrats recognize the dignity and human rights of all, regardless of characteristic or circumstance;

WHEREAS Democrats embrace the words of Eleanor Roosevelt when she asserts that human rights begin "in small places, close to home... where every [person] seeks equal justice, equal opportunity, equal dignity without discrimination. Unless these rights have meaning there," in our neighborhoods, "they have little meaning anywhere;"

NOW, THEREFORE, BE IT RESOLVED THAT the Democratic Party supports the creation of low-barrier shelters across our communities utilizing modeled best practices with input from served populations in order to provide an effective, safe, and humane response to the incidence of homelessness.

Affordable housing is generally defined as housing costs not exceeding 30% of household income; now, therefore, be it

RESOLVED that we support the following forms of housing relief at the local, state, and federal levels of government:

- Continue to provide federal funds for rental and mortgage assistance to persons caught by inflationary housing costs.
- Include immigrants, regardless of status, in subsidized rent and mortgage payments.
- Pass the Housing Survivors of Major Disasters Act (H.R., 3037, 2022) to address barriers preventing access to FEMA aid, and ensure that expanded options for proving home ownership apply retroactively.
- Pass federal legislation to permanently implement HUD's Mixed-Status Rule to provide access to federal housing assistance regardless of immigration status of family members.
- Promote state and local rental assistance programs to provide emergency rental and utility costs assistance and provide resources for homeowners struggling with mortgage payments.
- Enforce the federal enforcement mechanisms of the Fair Housing Act (Title VIII of the Civil Rights Act of 1968) including punitive damages and attorneys' fees as the Act provides.
- Support and enforce fair housing provisions of the North Carolina Human Right Act that apply to persons discriminated against because of race, color, religion, sex, national origin, physical or mental handicaps, and family status; and,

RESOLVED that we support the following economic recovery initiatives:

- Pass a Public Housing Act, to retrofit public housing and provide workforce training, and workforce training subsidies for residents.
- Enact a federal Home Owners Loan Corporation (HOLC) modeled after the HOLC provided in Roosevelt's New Deal; ensure loans are available to all.
- Repeal the Faircloth Amendment, which bans any net increase in public housing units.
- Increase funding for affordable housing programs at HUD and the USDA by increasing block grants to states to build, rehabilitate, or preserve housing targeted to extremely low income (ELI) households.
- Allow underwater homeowners to write down principal to the value of the property and refinance to take advantage of cheap federal credit, limited to the price of the median home following the guidelines of President Obama's Plan to Help Responsible Homeowners.
- Provide civil and criminal penalties against mortgage holders and related mortgage service providers for deceptive practices during repackaging and refinance negotiations; require explanation of optional payback choices, such as paying at end of loan term.
- Publicly funded universal child care shall be provided.
- Join with the National Low Income Housing Coalition (NLICH) to support the Campaign for Housing and Community Development Funding (CHCDF), a coalition working to increase resources for affordable housing and community development
- Publicize the availability to North Carolina jurisdictions of HOME-ARP funds from the America Rescue Plan to assist vulnerable populations such as individuals and households who are homeless or at risk of homelessness; and,

BE IT FURTHER RESOLVED that we support the following policy reforms to improve housing affordability for North Carolina residents:

- Subsidize housing equitably between homeowners and renters, e.g., federal mortgage-interest deduction (MID) and capital gains exemptions on homeowners.
- Increase the supply of affordable housing by including funds for the repair of existing units, including weatherization/energy efficiency, and construction of new units in any infrastructure package.
- Include housing investments for America's low-income households in any infrastructure package.
- Revise "not in my backyard" NIMBY zoning codes enacted by municipalities and counties that restrict high-density projects such as building heights.
- Encourage local and state governments to revise building codes to increase the availability of high-density housing. The average rent in North Carolina increased 20% from Jan. 2021 to Jan. 2022.
- Encouraging public transit-oriented developments.
- Require developers to include a certain number of affordable units within a larger market-rate development
- Achieve net zero carbon footprint for all residences by 2050.

- Increase funding for USDA and HUD programs, including those that provide funding to support affordable housing in rural areas and on Native American tribal lands.
- Address housing barriers to successful reentry into their communities for the nearly one in three Americans with a criminal record.

WHEREAS, our national immigration system is broken, it is unconscionable to leave millions of immigrants in legal limbo without a clear, simple path to citizenship(1); and,

WHEREAS, since 1990, Congress has not updated the quotas for the legal immigration system. During that time, the population of the United States has increased 30 percent and the economy has doubled. Quotas—to the extent that they exist at all—should be linked to economic growth (in the case of employment-based immigrants) or population growth (in the case of family-sponsored immigrants), so they don't immediately become antiquated(2); and,

WHEREAS, Congress treats immigrants differently based on where they were born (literally their place of birth—they can't even escape this system by getting citizenship in another country). No "country" (i.e. nationals or former nationals of that country) can receive more than 7 percent of the total green cards in a category. These per-country limits are why Indian immigrants sponsored by their employers may have to wait decades for a green card, while other immigrants sponsored by their employers don't have to wait at all. Congress should repeal the per-country limits and ban discrimination based on nationality(2); now, therefore, be it

RESOLVED, that the following relief be enacted:

- Release or parole all immigrants from detention,
- Impose an immediate moratorium on placing immigrants in detention,
- Reunite all children with their families immediately,
- Improve all detention center conditions immediately,
- End the 287(g) program under which local sheriffs cooperate with U.S. Immigration and Customs Enforcement (ICE),
- Permanently end mandatory detention of immigrants; and,

RESOLVED, that the following recovery be enacted:

- End federal prison sentences and criminal prosecution of immigrants crossing the border seeking freedom, safety, opportunity, or to reunite with their families,
- Allow immigration judges the discretion to consider individual circumstances during deportation proceedings,
- Allow immigration judges to revisit previous decisions made under the harsh 1996 immigration laws(3),

- Ban local police from acting as deportation agents or otherwise doing the work of ICE;
- Congress must provide the funding needed to clear immigration court backlogs and alleviate pressure on the immigration system; and,

BE IT FURTHER RESOLVED, that the following immigration reforms be enacted:

- Pass the Dream Act and the New Way Forward Act,
- Ban for-profit immigration jails,
- Abolish ICE,
- Limit deportation for drug convictions and other minor offenses that result from disproportionate enforcement of communities of color,
- Allow previous deportees to apply to return to the U.S.

WHEREAS, According to the World Bank, the United States spends more money on the military than the next nine countries combined and 12 times more than Russia[1]; and

WHEREAS, The United States taxpayer supports 750 military bases spread across 80 nations, in contrast to the United Kingdom's 145, Russia's 36, and China's five[2]; and

WHEREAS, As Representative Barbara Lee has said, "Year after year, this country pours billions into our already-astronomical defense budget without stopping to question whether the additional funding is actually making us safer. We know that a large portion of these taxpayer dollars are used to pad the pockets of the military-industrial complex, fund outdated technology, or are simply mismanaged[3];" and

WHEREAS, The United States is the world's leading arms seller; and

WHEREAS, The United States military is currently engaged in armed conflicts all around the world[4]; and

WHEREAS, The United States has used its military to engage in interventions around the world that, since the end of World War II, have not resulted in the establishment of democratic governments or flourishing societies - including, but not limited to, the invasions of Iraq and Afghanistan - but have resulted in millions killed or wounded, violations of human rights, degraded economies and natural environments , poverty and malnutrition, money lost to waste, fraud, and abuse, and a global revulsion for U.S. imperialism[5]; and

WHEREAS, The United States refuses to allocate the resources necessary to provide universal health care, quality public education, affordable housing, good jobs, food security, adequate disaster relief, infrastructure, safe air, water, and soil, or address the challenges of climate change; and

WHEREAS, President Biden said on February 4, 2021, that "Diplomacy is back at the center of our foreign policy," and called for a diplomacy-first foreign policy, yet the 2023 budget for the State Department was \$59.7 billion compared to a Pentagon budget of \$816.7 billion; and

WHEREAS, Stock prices for weapons contractors have soared since the Russian invasion of Ukraine, and weapons company leaders have spoken of the invasion as an "opportunity[6];" and

WHEREAS, The current Secretary of Defense former General Lloyd Austin served as a paid Board member of Raytheon Technologies before joining President Biden's cabinet, creating an apparent conflict of interest; and

WHEREAS, The combined CEO pay of the top 5 weapon makers - General Dynamics, Raytheon, Boeing, Northrop Grumman, and Lockheed Martin - exceeds \$100 million dollars totally and a total of \$287 million is paid to their top two dozen executives[7]; and

WHEREAS, Research done by Dr. Heidi Garrett-Peltier of Brown University indicates that spending \$287 million on productive activities would create thousands of jobs: 2,812 jobs in clean energy or infrastructure, 4,104 in health care, and 4,362 in education[8]; and

WHEREAS, Military conflict causes immense human suffering, disintegration of societies, degradation of the environment, and increases the possibility of nuclear conflagration[9]; and

WHEREAS, Dr. Martin Luther King Jr. prophetically stated "Mankind must put an end to war or war will put an end to mankind;" now, therefore, be it

RESOLVED, That the Democratic Party will encourage our elected leaders to support a 'diplomacy first' foreign policy; and

RESOLVED, That the Democratic Party will question and openly debate the economic, social, environmental, and moral effects of a militarized economy and foreign policy based on militarism; and

RESOLVED, That the Democratic Party will support Marc Pohan and Barbara Lee's People Over Pentagon Act which would slash \$100 billion from the nation's military budget and reallocate that money to urgent needs: from investments in education and healthcare to combating the climate emergency; and

BE IT FURTHER RESOLVED, That the Democratic Party will call for significantly increased investment in diplomacy, recognizing increasing militarization as the dangerous, escalating, and counterproductive factor it too often is.

WHEREAS, For more than a year, the people of Ukraine have been under attack by Russia in a war in which Russia has sought the total destruction of the Ukrainian nation and the decimation of its people; and

WHEREAS, Russia has committed uncounted crimes against the people of Ukraine - both violations of human rights and of war - including during previously established bilateral ceasefires; and

WHEREAS, As a sovereign nation, Ukraine has the right to direct its own foreign policy, including during the future peace process with Russia, without undue pressure from international actors including the United States; now, therefore, be it

RESOLVED, That the North Carolina Democratic Party and all its elected members continue their unequivocal support for Ukraine and its people in this ongoing, defensive conflict; and

RESOLVED, That the North Carolina Democratic Party and all its elected members continue to condemn the actions of and put pressure on Russia to end the conflict and make reparations to Ukraine for the damage they have caused; and

RESOLVED, That the United States continue its leading role in advocating for, directing, and supplying financial, humanitarian, and military aid to Ukraine and its people until such time that Ukraine chooses to resolve the conflict on their own terms; and

BE IT FURTHER RESOLVED, That, once the conflict comes to an end, the United States continue to advocate for, direct, and supply financial and humanitarian aid to Ukraine and its people to help restore its civil and economic infrastructure and avert other post-war crises that may arise.
